Willis Towers Watson Prices Offering of \$1,000,000,000 of Senior Notes

ARLINGTON, Va. and LONDON, Sept. 05, 2018 (GLOBE NEWSWIRE) -- Willis Towers Watson Public Limited Company (NASDAQ:WLTW) ("Willis Towers Watson"), today announced pricing of a registered offering (the "Offering") by Willis North America Inc. ("Willis North America"), an indirect wholly-owned subsidiary of Willis Towers Watson, of Willis North America's\$600,000,000 aggregate principal amount of 4.500% senior unsecured notes due 2028 and \$400,000,000 aggregate principal amount of 5.050% senior unsecured notes due 2048 (collectively, the "notes"). Payment of principal and interest on the notes will be fully and unconditionally guaranteed by Willis Towers Watson, and certain direct and indirect subsidiary entities of Willis Towers Watson.
